It is absolutely barbaric and it leaves me at a loss for words.

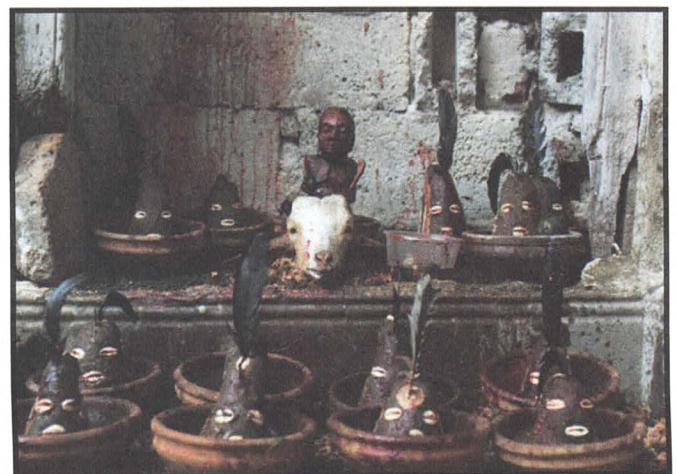

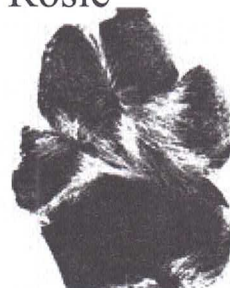

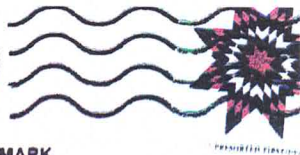
